QGSSSA Conditions of Entry Policy

In entering any property or venue at which the Queensland Girls' Secondary Schools Sports Association (**QGSSSA**) is conducting a sporting event, you agree that you and the persons for whom you are responsible (your attendees):

1. shall abide by and with all policies and guidelines issued for and on behalf of the owner/occupier of the venue which you are attending;
2. shall abide by and with all policies and guidelines issued for and on behalf of QGSSS , including the QGSSSA policy on photography (copies of all applicable policies available for perusal on request);
3. shall follow all directions given to you by any authorised employee or agent of the venue and/or the QGSSSA (**official**), such authority evidenced by their badge or accreditation material identifying the official as such;
4. acknowledge and agree that QGSSSA events are conducted in the spirit of fair competition and fraternity and that you and your attendees are not to interrupt or otherwise intervene in any competition or event or interfere with any competitor, umpire or official; save that appropriate verbal support and encouragement may be given to the person or team you and your attendees are attending to support. In giving appropriate verbal support and encouragement, you and your attendees shall not racially vilify, discriminate, harass, bully or intimidate any other person (including competitors, officials, umpires and other spectators and attendees) and you and your attendees shall otherwise abide by the provisions of the *Anti-Discrimination Act* and any other applicable similar legislation;
5. acknowledge that the venue is an alcohol, drug and smoke-free environment and agree and agree that you will not bring on to the venue any alcohol, non-prescribed drugs or drugs for "*recreational use*" and that you and your attendees may be excluded, at the absolute discretion of an official, if it is suspected that you or any of your attendees are under the influence of alcohol or drugs, or should you or any of your attendees smoke outside any designated smoking zones at the venue;
6. acknowledge and agree that if you and/or any of your attendees, in the absolute discretion of an official, are considered to have breached of any of these conditions of entry or associated QGSSSA policies, you and your attendees will immediately follow and abide by any direction or request of the official, including a direction that you and your attendees:
 - (a) provide your and/or your attendee's name, address, telephone numbers and details of the person/team/school which you and your attendees are attending to support; and
 - (b) remove yourself and your attendees from the venue immediately;
7. acknowledge and agree that a breach by your or your attendees of any of these conditions of entry or associated QGSSSA policies or a failure by you and/or your attendees to immediately follow any direction of an official may result in:

QGSSSA Conditions of Entry Policy

- (1) an automatic and immediate revocation of any licence given to you and your attendees to be present within the venue;
 - (2) you and your attendees being liable as trespassers; and
 - (3) the QGSSSA, at its absolute discretion, contacting the Queensland Police Service and pressing for charges of trespass to be laid against you and/or your attendees;
8. acknowledge and agree that should you or any of your attendees fail to follow any direction or request of an official, you consent to the use of reasonable physical force being applied by officials or persons under their direction and instruction to remove you and your attendees from the venue and for those persons to continue to exclude you and your attendees from the venue whilst QGSSSA events are being held for as long as the QGSSSA shall deem, in its absolute discretion, reasonable;
9. should an official deem it necessary to use reasonable physical force to remove you and your attendees: -
 - (1) you agree and waive, including on behalf of your attendees, any right to seek compensation or costs in respect of any injury, damage or loss sustained by you or your attendees as a result of such use of force; and
 - (2) you agree, including on behalf of my attendees, to indemnify the QGSSSA in respect of any cost, injury, loss or damage sustained by the QGSSSA, the venue owner and of any employee or agent thereof resulting from the use of such force.
10. By entering a venue, you are deemed to have read, understood, acknowledged and agreed with all of the above terms and conditions of entry and the associated QGSSSA policies.
